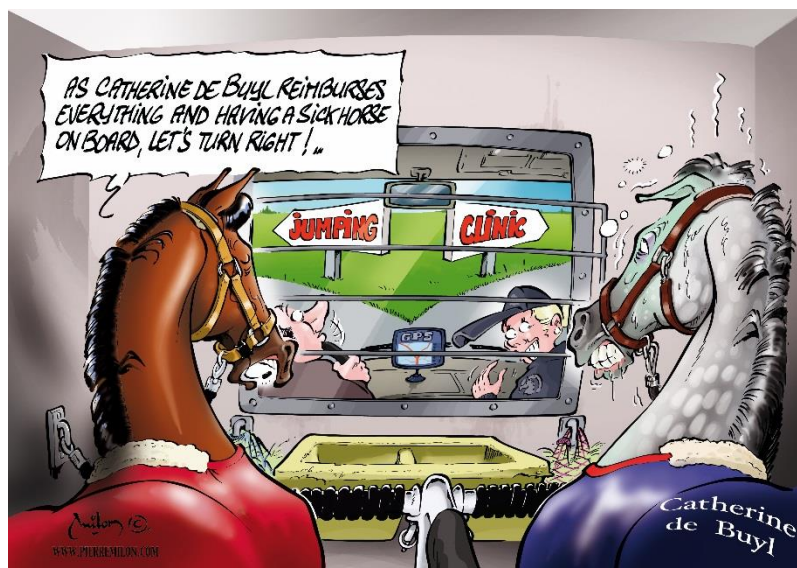

1. COVERAGE :

A . 12 MONTH MORTALITY BASIC COVER :

- **Agreed Value** : Horses are insured for all risks of mortality (disease and accident) **with 100 % of REIMBURSEMENT on the Insured Value.**
- All risks of mortality following to disease or accident **during a surgery** under total anaesthetics, if this surgery is required **to save the horse's live or to avoid a future lameness or disease.**
- Euthanasia for humane reasons.
- Theft
- **WORDWIDE COVERAGE -including transits** by any possible way even by air.
- Lightning, electrocution and drowning.
- Fire, **in your own stables as well.**
- Natural disasters.
- **Reimbursement of the hospitalisation and surgery fees due to colics** (including inguinal hernia) **with a reimbursement of maximum 4.000€ per year and per horse - WITHOUT DEDUCTIBLE**, whether the horse had been operated or not.



B. ADDITIONAL COVERAGE :

Our intervention in hospitalisation due to colics, is increased from 4.000 € to the limit chosen in the “Hospitalisation Fees”.

B. « HOSPITALISATION FEES” DUE TO ANY DISEASE OR ACCIDENT (MAJOR MEDICAL) + REVALIDATION:

- Reimbursement of the hospitalisation or surgery fees due to any disease or accident.
- In addition to the surgical procedures and hospitalization fees extension, this insurance is further extended to reimburse the INSURED, for reasonable and customary fees incurred during the policy period for Osteopathy, Equine Spa, Seawater or Swimming Rehabilitation Therapy, performed by a VETERINARY SURGEON or competent person directed by them, following the diagnosis by a VETERINARY SURGEON that the condition treated above necessitates the need for such Equine Spa, Seawater or Swimming Rehabilitation Therapy.
